MINUTE OF THE ENVIRONMENT COURT (16 November 2020)

Introduction

[1] This Minute is issued for the purpose of case management and responds to the matters raised in the memorandum filed by Southland Regional Council dated 9 November 2020.

Topic B6 (Infrastructure)

- [2] The Regional Council is still conferring with the parties who have an interest in Topic B6 as to whether they seek the assistance of Mr Dunlop, for the purpose outlined in the last Minute. I will direct they report back to the court by 27 November 2020.
- [3] If required, Mr Dunlop is available on 17 December 2020 in person or via AVL.



Topic B7 (Other Issues)

[4] Mediation for Topic B7 is currently scheduled for 15 – 17 December 2020. The Regional Council advises that, in agreement with the court's view, four weeks is unlikely to be enough time in which to complete the pre-mediation steps as directed.¹ Therefore, the Regional Council seeks that mediation for Topic B7 be set down in the first quarter of 2021. Counsel advise that no party has objected to this proposal.

[5] As requested, I will vacate the mediation. The Registry will be in contact directly with the parties regarding the Commissioner availability for mediation.

Directions

- [6] Accordingly, I direct:
 - (a) mediation for Topic B7 currently scheduled for 15 17 December 2020 is vacated;
 - (b) by Friday 27 November 2020, the Regional Council is to confirm whether they seek the assistance of Mr Dunlop in relation to Topic B6 on 17 December 2020 indicating a preference for an in-person meeting or an AVL event.
- [7] Leave is reserved for the parties to seek further (or amended) directions.
