Judge Borthwick advises:

As indicated in court, parties will be given the opportunity to file evidence in relation to the DIN and DRP maps SRC proposes to include in Schedule X. The court wishes to understand what the DRP and DIN maps are said to convey and secondly, clarify what is meant by N, TN and DIN and secondly, P, TP and DRP.

The SRC has indicated that it wishes to lead evidence from Dr Snelder.

To that end the court (and contrary to what we indicated earlier) will not hear submissions in relation to the maps today. The registry will liaise with parties in relation to a further hearing date although it is hoped that the evidence may come in as an agreed brief of evidence.
