MAY IT PLEASE THE COURT:

- This Memorandum of Counsel is filed on behalf of Federated Farmers Southland Incorporated (Federated Farmers).
- 2. By way of background:
 - In its Sixth Interim Decision the Court directed *inter alia* parties to propose an alternative rule regime to Rule 78 for the maintenance of modified watercourses;
 - (b) On 13 April the Court referred Policy 30 and Rule 78 to expert conferencing. A joint witness statement (JWS) was to be filed by 19 May, with the parties directed to file a memorandum setting out their position on any drafting in the JWS by 23 May;
 - (c) On 9 May the Environment Court recalled that part of the Sixth Interim decision relating to Rule 78, including the part directing the parties to propose an alternative rule regime;
 - (d) On 10 May Federated Farmers sought to have the expert conferencing set down for 15 and 18 May vacated on the basis that:
 - (i) The basis for the direction for expert conferencing no longer exists following the recall of the Sixth Interim decision;
 - (ii) The experts need to understand the scope of the changes the Court can direct to meaningfully conference on Policy 30 and Rule 78; and
 - (iii) If expert conferencing was to go ahead prior to resolution of the scope issue and the Court's clarification as to its interim decision on Rule 78, there is a significant risk that the product of that conferencing will not address the ultimate issue to be determined by the Court and result in additional expert conferencing on the matter;
 - (e) The conferencing went ahead as scheduled;
 - (f) On 19 May the Southland Regional Council sought an extension to the dates in (b) above;

- (g) On 22 May the Court granted the extension to the timetable directions with parties to file memoranda by 25 May. The Court also directed the parties to indicate whether they have questions for Ms McArthur.
- 3. Federated Farmers advises:
 - (a) It supports the Court's version of Policy 30;
 - (b) It supports the proposed permitted activity regime prepared by Ms
 Ruston that is attached to the JWS as Appendix 1; and
 - (c) It has questions for Ms McArthur.
