May it please the Court,

The following matters are respectfully submitted for the Director-General of Conservation Tumuaki Ahurei (the Director-General):

- The Director-General filed a section 274 Notice joining part of the appeal by Wilkins Farming Co (the Wilkins appeal) against the respondent Council's decisions on the proposed Southland Water and Land Plan (pSWLP).¹
- 2. The Director-General's interests were in the parts of the Wilkins appeal on:
 - a. Council decisions for the Physiographic Zone Policies 4 12 inclusive which were finally dealt with by the Court in the Agreed Provisions decision dated 23 December 2022.²
 - b. Appendix L.5 Groundwater Allocation as the appeal by the appellant was potentially contrary to the Director-General's own appeal on this Appendix in relation to the Te Anau aquifer.
- 3. The Director-General's appeal on Appendix L.5 Groundwater Allocation has been resolved.³
- 4. The appellant and Council have been in negotiations to resolve the outstanding matters on the Wilkins appeal, including on Appendix L.5. The Director-General has not been a part of those negotiations.⁴
- 5. I have previously advised counsel for the appellant and the Council that, as her appeal on Appendix L.5 is resolved, the Director-General has no further interest in Tranche 2.
- 6. Accordingly, the Director-General now gives notice of her intention to withdraw from her remaining interests in the Wilkins appeal and in Tranche 2.
- 7. Counsel for both the appellant and the Council have confirmed they have no issues as to costs.
