## Directions

[1] The Southland Regional Council ("the Council") will circulate to the parties in writing, as soon as possible, Mr Maw's description provided during the conference of issues that attach to interfacing the Resource Management (Freshwater Farm Plans) Regulations 2023 and pSWLP Appendix N FEMP provisions. Relevant considerations include the staged introduction of the Regulations by catchment; application of sections 20A and 86F RMA and rule 20; amendments to pSWLP Appendix N; the date when applicable pSWLP provisions are made operative; and desirability of not duplicating farm plan preparation under different regimes.

[2] The parties will collaborate in proposing an approach for dealing with the matters at [1], including an appropriate date for when relevant pSWLP provisions are made operative and related Appendix N amendments. The proposed approach is to be included in the Council's memorandum to be filed 18 August 2023.<sup>1</sup>

[3] Should a party wish to express a different view from the Council on matters traversed at [2], they are to be recorded in the 18 August 2023 memorandum.

[4] Should it be relevant, the 18 August 2023 memorandum may propose directions for both the filing of submissions on any matters not agreed between the parties and a process for determining such.
