RECORD OF PRE-HEARING CONFERENCE

(15 February 2023)

Introduction

[1] Following the release of the fifth Interim Decision, a pre-hearing

conference was held for the purpose of case management on 14 February 2023.

Stay of proceedings

[2] Directions have been made for application(s) to stay the proceedings to be

filed.

[3] Further to paragraph [279] of the fifth Interim Decision, a decision whether

to direct further expert evidence on the topic of significant adverse effects on

aquatic life will be made following the determination of any stay application.

[4] Parties are strongly encouraged to confer and agree on the scope of the stay

before filing an application.

Appendix N: FEMP

[5] Directions regarding the sense checking of Appendix N: FEMP will be

made following the determination of any application for stay filed. The direction

given at [18(b)] of the Minute dated 10 February 2023 is cancelled. Meantime,

parties are to confer on the process to apply to the sense check and be prepared

to propose directions at the next pre-hearing conference.

Appendix N: FEMP - sacrifice paddocks

[6] Agreeing with the Regional Council, further consideration of the treatment

of sacrifice paddocks in Appendix N is required.

[7] Addressing an issue raised in the Regional Council's reporting memorandum dated 9 February 2023, a possible amendment may be to amend cl 13(d) to read:

- (a) <u>excluding sacrifice paddocks</u>, confirm how the following practices are to be implemented:
 - (i) downslope grazing or a 20m 'last-bite' vegetated strip at the base of the slope; and
 - (ii) back fencing to prevent stock entering previously grazed areas.

[8] The Council has yet to respond to paragraph [375(b)] of the fifth Interim Decision as to whether the <u>FEMP</u> is to address the use of sacrifice paddocks by all stock or cattle¹only. The Regional Council is to clarify its thinking on this matter and secondly, indicate whether the FEMP's Winter Grazing Plan provisions at cl 13 should include a sacrifice paddock provision requiring the identification of paddocks to be resown after grazing and when this is to occur, weather permitting.

The Regional Council's responses to certain paragraphs

[9] The direction given in the Minute dated 10 February 2023 at [15] for parties to file a memorandum if disagreeing with the Regional Council's responses to questions/directions at paragraphs 231, 279, 313, 314, 375, 397-399, and 455 of the fifth Interim Decision is <u>enlarged</u> to **Friday 17 February 2023**. Further directions may then issue.

Directions

[10] I <u>direct</u>:

¹ Cattle or alternatively, "cattle or deer" used in the 9 February 2023 SRC definition of sacrifice paddocks is accepted.

Stay of Proceedings

(a) any application for a stay of proceedings is to be filed by Wednesday22 February 2023; and

(b) replies to any application are to be filed by **Monday 27 February 2023**.

Other directions

[11] By **Monday 27 March 2023** the Regional Council will file a memorandum clarifying whether, in the context of sacrifice paddocks, the FEMP is to address cattle/deer or all stock, and to propose further amendments to the proposed plan on this topic (as may be required).

[12] The proceedings will be set down for a further pre-hearing conference at **9.00 am** on **Wednesday 1 March 2023**.
