#### PURPOSE OF THE MEETINGS

The purpose of the meetings was set out in the Court's Minute dated 5 August 2019.

- Counsel, together with their expert witnesses are to propose a programme of work
  for consideration and direction by the court. The output of the programme will be to
  identify ecological and cultural indicators of health. The work will also inform how the
  water quality in waterbodies that are not degraded will be maintained.
- 2. Scientific advisors are to identify and confirm they have access to the information that is relevant to inform the directions proposed by the parties.
