MAY IT PLEASE THE COURT

- This Memorandum of Counsel is filed on behalf of the Southland Regional Council (**Council**) in respect of the appeals against the Council's decision on the proposed Southland Water and Land Plan (**pSWLP**).
- This Memorandum addresses the proposed hearing schedule, as indicated in our Memorandum of Counsel dated 1 March 2019.

Proposed hearing schedule

- In accordance with the availability of the witnesses, and as set out in our Memorandum of Counsel dated 1 March 2019, Counsel has prepared a draft schedule with a proposed order of parties that will accommodate any witness unavailability during the hearing. Counsel has circulated this proposed schedule among the parties to seek their comment. No party has raised any issue with the proposed schedule. The proposed schedule is attached in **Appendix A**.
- This schedule proposes that the hearing proceeds on a party by party basis rather than by topic or area of expertise. Counsel considers that if the hearing were to be heard on a topic or expertise basis, individual witnesses may be required to be available on a number of occasions and may be recalled to provide evidence on multiple topics (due to the overlap in topics addressed by some witnesses). Counsel considers this may lead to inefficiencies in the hearing process.
- The proposed schedule follows, as far as possible, the evidence exchange timetable. However due to the large number of parties to these appeals and the availability issues of some parties, Counsel proposes to schedule some parties where they have availability, rather than strictly following the evidence exchange timetable.
- Counsel notes that the proposed schedule will need to be somewhat flexible due to the uncertainty in the length of time required for each witness, which will depend on the extent of cross examination and questions from the Court.
- In addition, the timing in the schedule will depend, in part, on the format of the hearing. Those parties that have not filed evidence for the Topic A hearing have been listed after the proposed hearing schedule in Appendix A. If these parties intend to present legal submissions, they

- will need to be added into the schedule at the appropriate time (in light of the Court's directions as to the presentation of legal submissions, as discussed below).
- 8 Counsel seeks direction from the Court as to its preference as to how the hearing will proceed, particularly in relation to the presentation of opening and closing legal submissions.
- 9 Given the number of parties, Counsel considers that there may be efficiencies for each party to give a brief opening before their witness/es present evidence, and for each party to give full written closing legal submissions once all evidence has been heard. This would enable all parties to provide focussed legal submissions in light of all of the evidence and avoid the need for both fulsome opening and closing submissions, particularly by those parties being heard near the commencement of the hearing. This approach would also avoid any natural justice issues that might result from parties being heard in a different order.
