## MINUTE OF THE ENVIRONMENT COURT Topic A

(10 June 2020)

#### Introduction

- [1] This Minute is released for the purpose of case management in relation to the hearing currently set down in Christchurch from 15 June 2020 for three days.
- [2] The hearing was set down for three days prior to the notice of motion seeking a ruling on scope being filed.<sup>1</sup> As the scope issue is to be heard concurrently with the matters set down at the pre-hearing conference held 10 February 2020, the court is concerned that three days may no longer be sufficient.<sup>2</sup>
- [3] If extra time is required the hearing will continue on 18 and, if necessary, 19 June 2020 in Christchurch. The court anticipates that all evidence will be heard on Monday 15 June 2020 and will work with counsel to accommodate prior commitments.
