### Good afternoon

The bench has read the SRC memorandum dated 23 June 2022 and is very concerned that the timeframe suggested by the parties to conclude this hearing may preclude the court issuing its interim decision prior to September (as indicated). This in turn may impact on other appeals scheduled from October.

Subject to what Ms Gepp has to say, the court requires Mr McCallum-Clark give his evidence in reply on 18 July 2022 (including any amendments to the provisions he supports & s32AA report) with closing submissions to commence on 19 and 20 July and continuing to be heard on 3-4 August 2022 if need be. Counsel can organise the hearing schedule to accommodate any planned absences on those dates.

To that end Judge Borthwick directs:

#### 1. By Wednesday 29 June 2022:

- a. Ms Gepp is to advise whether the court can be accommodated and the hearing resume on 18<sup>th</sup> July with Mr McCallum-Clark's evidence; and
- b. SRC to propose a filing date for Mr McCallum-Clarks evidence in reply and s 32AA report (allowing the court at least 3 reading days);.
- 2. The joint witness statement from conferencing planners and farm systems experts is to be filed Friday 1 July 2022 together with a memorandum of counsel advising which witnesses are to be recalled when the hearing next resumes to present the same (NB: with the agreement of the parties, one or more witnesses may present on behalf of the conferencing parties).

Further directions will be made after the final sitting days are confirmed.
