Good afternoon

I have referred the memorandum filed by Ms Rusher dated 22 February 2022 to Judge Borthwick who responds:

- 1. I do not consider the directions sought are required and decline to make the same.
- 2. If following the conferencing of expert witnesses, the parties represented by Ms Rusher agree with the other parties on proposed amendments to the pSWLP, then
 - a. Mathew McCallum-Clark was to file evidence in support of the agreed provisions; and
 - b. with reference to paragraphs [10]-[11] and [42] of the Record of Judicial Conference held 10 February 2022,
 - parties were to (a) identify any witnesses to give technical evidence in support of the agreed amended provisions by Friday 18 February 2022; and (b) file that technical evidence by Friday 25 February 2022.
- 3. Having consulted with the parties, SRC filed a memorandum on 18 February 2022 identifying witnesses to give technical evidence in support of the amended provisions.
- 4. If the parties agree with Ms Rusher that additional technical evidence is required in relation to amendments supported by Mr McCallum-Clark (in addition to the evidence agreed to be called by Rayonier), this is to be filed Friday.
