#### MINUTE OF THE ENVIRONMENT COURT

Courtroom capacity (24 February 2022)


- [1] This Minute addresses the capacity of the two courtrooms in use for these proceedings.
- [2] Social distancing (now) requires 2 metre separation between all persons in

court and this has further reduced courtroom capacity.1

- [3] In response to a query from Wynn Williams concerning courtroom capacity,<sup>2</sup> I remind parties that the protocol is for hearings to be conducted to the extent possible by remote participation.<sup>3</sup>
- [4] I am satisfied that the interests of justice will be served if the 'all of parties' hearing is conducted remotely via AVL.<sup>4</sup> The Regional Council was directed to report to the court this week on the parties' views as to use of AVL for the 'disputed provisions' hearing.
- [5] In-person hearings (or a hybrid of in-person and remote participation) will be conducted where it serves the interests of justice to do so. Any party wishing to be present in court will need to seek leave and satisfy me that their attendance is in the interests of justice.<sup>5</sup>
- [6] Leave is reserved for the parties to seek further (or other) directions.

<sup>1</sup> The hearing is set down in Courtroom 1 for the first week and Courtroom 13 for the remainder. In Courtroom 1 a transportable AVL facility will be used with a single camera. This means the Registry can zoom in on one person (e.g. a lawyer or a witness, but not both). It is therefore preferable that all of week one is conducted remotely as participants are required to be situated a standard distance from a camera.
