Judge Borthwick directs:

In the first Interim Decision 2019 NZEnvC 208 the court made findings in relation to Policies 45, 46 and 47.

In 2022 the SRC supports the amendments to Policies 46 and 47, but only carries forward the change to Policy 46 into the October Consolidated Plan.

It may be that we have overlooked a submission, but as matters presently stand it appears that the amended wording for the three policies set out in the 2019 Interim Decision has not been the subject matter of further evidence or submission.

*Parties are to file a memorandum by **Friday 9 December 2022** if they oppose the inclusion of the amended provisions, giving reasons. If no party responds, the decision of the court will be to approve the amendments set out in the 2019 Interim Decision and update the Consolidated Plan accordingly.*
