# MEMORANDUM OF COUNSEL FOR FEDERATED FARMERS CLARIFYING AND CONFIRMING RELIEF SOUGHT

#### **MAY IT PLEASE THE COURT**

- 1. As outlined in my 11 April 2022 submissions, Federated Farmers takes issue with the proposed methods in the pSWLP that control:
  - (a) The area of a landholding able to be used for intensive winter grazing (IWG);<sup>1</sup>
  - (b) Pasture-based grazing in the winter months;<sup>2</sup>
  - (c) Cultivation;<sup>3</sup>
  - (d) Feed pads / lots;4
  - (e) Sacrifice paddocks;5 and
  - (f) Stock access to wetlands.6
- 2. My submissions of 11 April 2022 explained the disputed provisions were somewhat of a moving target<sup>7</sup> for Federated Farmers and that it was continuing to engage to further develop the drafting.<sup>8</sup> I indicated that an update would be provided to the Court and parties in advance of the reconvened hearing.
- 3. An update was then provided by way of memorandum on 25 May 2022.
- 4. On 1 June 2022, the Judge directed parties to file memoranda by 9am on Tuesday 7 June 2022 "recording any errors" identified in the May version of the Consolidated Plan "together with the parties' proposed relief."
- 5. Each method is address below, for completeness.

# **Rule 20A: Intensive Winter Grazing**

6. Rule 20A(a)(i) should read:

Intensive winter grazing does not occur on more than 15% of the area of the landholding.

- 7. This is on the basis there is no scope to introduce the base text used in (a)(i).
- 8. Rule 20A(ii) should be deleted. This is on the basis there is no scope to introduce a slope control on IWG.
- 9. If either of the above requests are not successful, Rule 20A(aa) is required.

# Rule 20B: Pasture based grazing in the winter months

10. The position remains as set out in my memorandum of 25 May 2022.

### **Rule 25: Cultivation**

- 11. The new rule framework is correctly shown in the Consolidated Plan.
- 12. A flowchart endeavouring to simply explain the rule framework is **attached**.

# Rule 35A: Feed Pads

13. The relief is correctly shown in the Consolidated Plan.

## Rule 35B: Sacrifice Paddocks

14. Rule 35B(a)(vii) should read:

A Farm Environment Plan for the landholding is:

- prepared and certified in accordance with Appendix N;
- implemented by the landholder completing the practices, actions and mitigations specified in the FEP in accordance with the timeframes set out in the FEP.
- 15. Otherwise, the relief is correctly shown in the Consolidated Plan.

#### Rule 70: Stock Exclusion from Water Bodies

- 16. After reflecting on the answers to cross-examination and the scope of appeals to Rule 70, a revised approach is now put forward:
  - (a) Amend (ca) as follows:

The disturbance of the bed of a lake, river er, modified watercourse or natural wetland by sheep, other than as regulated by Rule 70(a) and 70(b), is a permitted activity, provided the following conditions are met:

- (i) the waterbody is not already fenced to prevent sheep access;
- (ii) the sheep are not being break fed or intensively winter grazed in the adjacent paddock;
- (iii) there is no significant de-vegetation leading to exposure of soil of the bed and banks, pugging or alteration to the profile of the bed and banks, other than at fords or stock crossings; and
- (iv) for natural wetlands, the stocking rate in the adjacent paddock does not exceed 6 su/ha; and
- (v) A Farm Environmental Management Plan is:
  - (A) prepared, and certified, and compliance with it is audited, in accordance with Appendix N; and
  - (B) implemented by the landholder completing the practices, actions, and mitigations specified in the Farm Environmental Management Plan in accordance with the timeframes set out in that Plan.
- (b) Replace (cb) with:

The disturbance of the bed of a natural wetland by cattle, deer or pigs is a non-complying activity.

(c) Amend (d) as follows:

Bed disturbance activities that do not comply with Rule 70(c) or 70(ca) are a non-complying activity.
