MAY IT PLEASE THE COURT

- 1 Counsel seeks leave to be excused from the court hearing other than when appearing for Mr Hamish English, a section 274 party to the appeal by Aratiatia Ltd (ENV-2018-CHC-029) for the reasons set out below.
- The dates of hearing for this matter were initially scheduled for earlier in 2022.
- On that basis, counsel committed to appearing at a three-week arbitration proceeding for the 14th November to 2nd of December, such dates being the sole period in 2022 where all counsel and the arbitrator were available for that hearing. When the Tranche 3 hearing dates were vacated, Counsel advised the Registrar that Mr English was not available in the proposed hearing period of 14th to 18th November.
