- Z Energy Limited, BP Oil New Zealand Limited and Mobil Oil New Zealand Limited (the Oil Companies) wish to be a party to the proceedings between Alliance Group Limited (Appellant) and the Southland Regional Council (Respondent) in relation to the Respondent's decisions on submissions to the Proposed Southland Water and Land Plan (the pSWLP).
- 2. The Oil Companies are interested in the following parts of the proceedings:
 - Appeal points 10(a), 10(b) and 10(c) regarding Objectives 13, 13A, and 13B.
- 3. The Oil Companies lodged submissions on the pSWLP on the subject matter of the proceedings.
- 4. The Oil Companies are not trade competitors for the purposes of section 308D of the Resource Management Act 1991.

 - 6.1 The Oil Companies are not generally opposed to the Appellant's position regarding Objectives 13, 13A and 13B. In particular evidence was presented by the Oil Companies in relation to the avoid threshold in Objective 13 and the zero effects threshold for cumulative effects on human health. The Oil Companies seek to ensure that any amendments to the objectives provide appropriately for the use of hazardous substances and discharges from contaminated land.
- 7. The Oil Companies agree to participate in mediation or other alternative dispute resolution of the proceedings.
