- I, Lou Sanson, Director-General of Conservation (the Director-General) wish to be a
 party to an appeal against part of the decision of the Southland Regional Council on the
 Proposed Southland Water and Land Plan (the proposed Plan) by Beef + Lamb (the
 appellant), ENV 2018 CHC 000034 (the notice).
- 2. I made a submission on the proposed Plan¹, in particular on Policy 18² and Rule 70³.
- 3. I am not a trade competitor for the purposes of section 308C or section 308CA of the Resource Management Act 1991 (RMA).
- 4. I am interested in all of the appeal.
- 5. My interests are as follows:

Policy 18 – Stock exclusion from waterbodies

- 5.1. In paragraph 6 9 of its notice, the appellant appeals that part of the decision dealing with Policy 18 paragraph 2A as the appellant considers the policy is unclear in its scope and application.
- 5.2. The appellant seeks to amend Policy 18.2A to:
 - 5.2.1. state what measure or standard will be used to specify levels of *E.coli* that would preclude contact recreation; and
 - 5.2.2. provide guidance on which waterbodies are considered relevant for contact recreation purposes.

Rule 70 – Stock exclusion from waterbodies

- 5.3. In paragraphs 10 11 of its notice, the appellant appeals that part of the decision dealing with Rule 70 and seeks relief:
 - 5.3.1. to define what a 'stock unit' is in the glossary; and
 - 5.3.2. exempt sheep from part of the Rule.

Policy 18 – Stock exclusion from waterbodies

- 6. I support the relief sought in the notice with respect to Policy 18 paragraph 2A. The reasons for supporting this are as follows:
 - 6.1. Clarification of Policy 18 is helpful, I recognise that Appendix E (Water Quality Standards) and Appendix G (Popular bathing sites) could be referred to in the Policy to provide this clarification.
 - 6.2. Clarification of Policy 18 paragraph 2A will:
 - 6.2.1. ensure the National Policy Statement for Freshwater Management 2014 (NPSFM) is given effect to as required by section 67(3) of the RMA, in particular: Objectives A1, A2 and A4; and Policy A5.
 - 6.2.2. ensure that the Southland Regional Policy Statement (SRPS) is given effect to as required by section 67(3) of the RMA, in particular: Objectives WQUAL.1 and WQUAL.2, and Policies WQUAL.2 and WQUAL.5.

<u>Rule 70 – Stock exclusion from waterbodies</u>

- 7. I support in part the relief on Rule 70 seeking a definition for 'stock unit' as this will provide clarity in the proposed Plan.
- 8. I oppose in part the relief on Rule 70 seeking an exemption of the application of Rule 70(e) for sheep. The reasons for opposing this relief are as follows:
 - 8.1. Sheep faeces are a significant contributor to concentrations of *E. coli* and other micro-organisms found in waterbodies in the Southland region.
 - 8.2. The proposed exemption for sheep is contrary to the RMA including sections 15, 69(3) and 70;
 - 8.3. The proposed exemption for sheep fails to give effect to:
 - 8.3.1. the NPSFM, including Objectives A1 and A2, and Policy A5.
 - 8.3.2. in the coastal environment, the proposed exemption fails to give effect to New Zealand Coastal Policy Statement, including Policy 21(d).
 - 8.3.3. the SRPS including Objectives WQUAL.1 and WQUAL.2, and Policies WQUAL.1 and WQUAL.2.

9. I agree to participate in mediation or other alternative dispute resolution of the proceedings.
