1 Invercargill Airport Limited ("**IAL**") wishes to be a party to the following proceedings:

(a) the appeal by Royal Forest and Bird Protection Society of New Zealand Incorporated ("**the Appellant**") to the Environment Court against the decisions of the Southland Regional Council ("**the Respondent**") on the Proposed Southland Water and Land Plan ("**the Proposed Plan**").

2 This notice is made upon the following grounds:

(a) IAL submitted on the Proposed Plan to which this appeal relates and has an interest in these proceedings that is greater than the public generally.

3 IAL is not a trade competitor for the purposes of section 308C or 308CA of the Resource Management Act 1991 ("**the Act**" or "**the RMA**").

The Appellant's relief too narrowly focuses the objective to the effects generated by regionally significant, nationally significant and critical infrastructure and does not provide for consideration of the effects of other activities on regionally significant, nationally significant and critical infrastructure.
