1. South Wood Export Limited (“SWEL”), on behalf of Kodansha Treefarm New Zealand Limited and Southland Plantation Forest Company of New Zealand Limited, appeals against the decisions of Southland Regional Council on the Proposed Southland Water and Land Plan (“PWLP”).
2. SWEL made a submission on the PWLP on 1 August 2016 and made further submissions on 11 August 2017.
3. SWEL received notice of the decisions on 4 April 2018.
4. The decisions were made by Southland Regional Council.
5. SWEL is not a trade competitor for the purposes of section 308D of the Resource Management Act 1991 (“RMA”).

Provisions being appealed

The decision (or part of the decision) that I am appealing is:

1. *Definition of “cultivation”* (SWEL submission point 758.1) being a decision not to exclude stick-raking from the definition of “cultivation” in the PWLP to the effect that restricted discretionary activity consent will be required for any stick-raking performed outside the conditions set out in Rule 25(a).
2. *Rule 25(a)(iv)* (SWEL submission point 758.1) being a decision not to redraft Rule 25 or amend the definition of “cultivation” so that the slope restriction in Rule 25(a)(iv) in the PWLP does not apply to aerial spraying, to the effect that restricted discretionary activity consent will be required for any aerial spraying undertaken on land with a slope greater than 20 degrees.

Reasons for appeal

3. The reasons for this appeal are that, in the absence of relief sought, Council’s decision:
 - 3.1 Will not achieve the purposes of the Act;
 - 3.2 Is contrary to Part 2 and other provisions of the Act;
 - 3.3 Will not promote the efficient use and development of natural and physical resources; and

- 3.4 Does not represent the most appropriate means of exercising Council's functions, having regard to the efficiency and effectiveness of other available means and is therefore not appropriate in terms of section 32 and other provisions of the Act.
4. Without limiting the generality of the above, further specific reasons for the appeal are set out below.

Appeal point 1: Definition of "cultivation"

5. The definition of "cultivation" in the PWLP includes reference to "mechanical tillage". Pursuant to Rule 25(a), any mechanical tillage performed outside the conditions set out in paragraphs (i) to (iv) inclusive will require restricted discretionary activity consent.
6. In its submission SWEL requested that the definition of cultivation specifically exclude stick raking, as stick raking (while not typically referred to as "tillage") is performed mechanically and is involved in the preparation of the ground for planting and replanting forestry.
7. Council rejected this request. There were no reasons given for this in the decision report.
8. SWEL appeals this decision on the basis that:
- a. The cultivation restrictions mean that SWEL will need to obtain resource consent nearly every time it needs to plant or replant forestry. This places an unreasonable and unfair onus on SWEL that is not practical in terms of the economic viability of forestry generally.
 - b. Stick raking is a method of removing debris, is performed above the ground and is not a method of tillage.
 - c. SWEL sought clarification from Council as to whether it would be required to obtain consent under the PWLP in respect of stick raking performed outside the conditions set out in Rule 25(a). Council's response on 9 May 2018 stated:

"Stick-raking is not considered to be cultivation so a consent would not be required".

Accordingly, SWEL seeks the exclusion of stick raking from the definition of cultivation for clarity and consistency.

Appeal point 2: Rule 25(a)(iv)

9. Rule 25(a)(iv) provides that any cultivation performed on a slope over 20 degrees will require restricted discretionary activity consent. As the definition of "cultivation" in the PWLP includes herbicide spraying, any aerial spraying performed by SWEL on slopes over 20 degrees will be a restricted discretionary activity.

10. In its submission SWEL requested clarification that aerial spraying (excluding spot spraying) would not be included in the restriction on cultivating land with a slope greater than 20 degrees.
11. Council rejected this request. Instead, Council amended the definition of cultivation to include all herbicide spraying except spraying undertaken solely for the control of pest plant species.
12. SWEL appeals this decision on the basis that:
 - a. Many of SWEL's forestry blocks contain land with a slope greater than 20 degrees. Spraying to remove weeds and control weed plant growth (including pest plant species) is vital to preparing land for the planting and replanting of a forest crop. The slope restriction means that SWEL will need to obtain resource consent every time it needs to plant or replant forestry. This places an unreasonable and unfair onus on SWEL that is not practical in terms of the economic viability of forestry generally.
 - b. SWEL plants several species of trees (pines and eucalypts) which are susceptible to certain chemicals (particularly eucalypts) which means there is a limited selection of sprays that can be safely applied post-planting. This means spraying prior to planting is essential to control weed growth/pest plant species.
 - c. Spraying prior to planting or replanting does not mean all soil is laid bare to the elements; it simply restricts further growth for a period. The vegetative matter remains as a litter layer. It therefore does not pose a significant risk to soil loss, particularly with regards to soils with lower erosion classification.
 - d. Typical ground conditions in forestry areas means most spraying is aerial spraying. Standard industry requirements are that aerial spraying in forest operations are controlled by approved operators with advanced flight guidance & ground positioning systems, spray drift calculation models, live mapping and supported by up to date weather forecasting.
 - e. The decision report provides that:

"We are satisfied, for the reasons set out by the section 42A authors, that cultivation on slopes in excess of 20 degrees should be scrutinized through a consent process."

However, the section 42A report provides that a consent process is *"more appropriate for higher-risk cultivation, in order to ensure that sediment run-off risk from cultivation is actively managed"*. Aerial spraying is not high-risk cultivation and therefore should not be subject to the consent process pursuant to Rule 25(a)(iv).

Relief sought

13. SWEL seeks the following relief:

13.1.1 The definition of "cultivation" in the PWLP is amended as follows:

"Cultivation

Preparing land for growing pasture or a crop by mechanical tillage (excluding stick raking), direct drilling, herbicide-spraying, or herbicide spraying followed by over-sowing for pasture or forage crops (colloquially referred to as 'spray and pray'), but excluding any spraying undertaken solely for the control of pest plant species."

13.1.2 In the event the definition of "cultivation" is not amended in accordance with paragraph 13.1.1, then Rule 25(a)(iv) is amended as follows:

"cultivation (excluding aerial herbicide spraying for forestry purposes) does not occur on land with a slope greater than 20 degrees."

- 4 The submitter cannot gain an advantage in trade competition through this submission

Specific provision

- 6 In general, this submission is in support of the notified version of the proposed Water and Land Plan ("WLP").
- 7 The specific provision that this submission relates to is Rule 25 – Cultivation on sloping ground.

Decision sought

- 8 The submitter seeks that the wording of the rules in the WLP is retained as proposed, subject to the amendments requested below.
- 9 The submitter supports the proposed Rule 25 and seeks the following:
- (a) Clarification by way of advice note or redrafting, that the definition of "cultivation" does not include "stick raking", a method commonly used by the forestry industry to control debris above ground;
 - (b) Clarification by way of advice note or redrafting within Rule 25 that the restriction on cultivation on land with a slope greater than 20 degrees does not apply to aerial spraying (excluding spot spraying); and
 - (c) Clarification by way of advice note or redrafting within Rule 25 that Environment Southland will consider, when deciding whether to grant consent under Rule 25(c), the importance of soil type, angle of cultivation and other specific controls employed by the applicant to prevent soil movement.

Detail of submission

Clarification that the definition of "cultivation" does not include "stick-raking"

- 10 The submitter generally supports the proposed wording of Rule 25 as it allows cultivation as a permitted activity except in certain circumstances. Stick-raking is a method used by forestry operators to clear above-ground debris, but is not intended to "cultivate" the land in the ordinary sense of the word. The submitter seeks clarification that stick-raking is not included in the definition of cultivation.


Clarification that the slope restriction does not apply to aerial spraying

- 11 The submitter would also like clarification that the slope restriction in Rule 25(a)(ii) does not apply to aerial spraying. Rule 25(a)(ii) specifies that mechanical cultivation does not occur on land with a slope greater than 20 degrees, however because cultivation refers to spraying (excluding spot spraying), it is unclear whether aerial spraying on land with a slope greater than 20 degrees is permitted.

Inclusion of matters for Environment Southland to consider when granting consent under Rule 25(c)

- 12 The submitter generally supports the proposed wording of Rule 25(c) as it allows for Environment Southland to grant consent on a restricted discretionary basis in respect of cultivation that does not meet one of the conditions set out in Rule 25(a) or (b). The submitter seeks clarification that Environment Southland will, in addition to the matters set out in Rule 25(c), consider the type of soil the consent application relates to, the angle of cultivation proposed by the applicant and other controls proposed by the applicant to prevent erosion or soil movement. The submitter considers these matters to be extremely important in managing adverse effects of cultivation on sloping ground.


Specific provision

- 6 In general, this submission is in support of the notified version of the proposed Water and Land Plan ("WLP"), and is in addition to South Woods submission dated 1 August 2016.
- 7 The specific provision that this submission relates to is Rule 25 – Cultivation on sloping ground as proposed to be amended by the Section 42A Report, and the Glossary of the WLP.

Decision sought

- 8 The Section 42A Report recommends Rule 25(a)(iii) be amended by adding after the words 'mechanical cultivation does not occur on land with a slope greater than 20 degrees (moderately steep)', or 'other cultivation on land with a slope greater than 25 degrees'. South Wood submits that this does not provide any clarity given that neither of the terms 'mechanical cultivation' or 'other cultivation' are defined. South Wood would like to see the meanings of the different terms used (or recommended by the Section 42A Report to be used) in the Proposed Plan of 'cultivation', 'mechanical cultivation' and 'other cultivation' clarified in the glossary of the WLP.

4. the potential benefits of the activity to the applicant, the community and the environment;
 5. the potential effects of the farming activity on surface and groundwater quality and sources of drinking water;
 6. monitoring and reporting undertaken to assess the effectiveness of any mitigation implemented.
- (e) The use of land for a farming activity that is not specified as a permitted, restricted discretionary or prohibited activity under Rule 20(d) is a discretionary activity.

Rule 24 – Incidental discharges from farming

- (a) The discharge of nitrogen, phosphorus, sediment or microbial contaminants onto or into land in circumstances that may result in a contaminant entering water that would otherwise contravene section 15(1) of the RMA is a permitted activity, provided the following conditions are met:
- (i) the land use activity associated with the discharge is authorised under Rules 20, 25 or 70 of this Plan; and
 - (ii) any discharge of a contaminant resulting from any activity permitted by Rules 20, 25 or 70 is managed to ensure that after reasonable mixing it does not give rise to any of the following effects on receiving waters:
 - (1) any conspicuous oil or grease films, scums or foams, or floatable or suspended materials; or
 - (2) any conspicuous change in the colour or visual clarity; or
 - (3) the rendering of fresh water unsuitable for consumption by farm animals; or
 - (4) any significant adverse effects on aquatic life.
- (b) the discharge of nitrogen, phosphorus, sediment and microbial contaminants onto or into land in circumstances that may result in a contaminant entering water that would otherwise contravene section 15(1) of the RMA and that does not meet one or more of the conditions of Rule 24(a) is a non-complying activity.

Rule 25 – Cultivation

- (a) The use of land for cultivation is a permitted activity provided the following conditions are met:
- (i) cultivation does not take place within the bed of a lake, river (excluding ephemeral rivers where cultivation is permitted under Rule 20(aa)), artificial watercourse, modified watercourse or natural wetland; and
 - (ii) cultivation does not take place within a distance of 5 metres from the outer edge of the bed of a lake, river (excluding ephemeral rivers where cultivation is permitted under Rule 20(aa)) artificial watercourse, modified watercourse or wetland and
 - (iii) cultivation does not occur at an altitude greater than 800 metres above mean sea level; and
 - (iv) cultivation does not occur on land with a slope greater than 20 degrees.⁷
- (b) The use of land for cultivation that does not meet the setback distance of Rule 25(a)(ii) is a permitted activity provided the following conditions are met:
- (i) cultivation does not take place within the bed of a lake, river (excluding ephemeral rivers where cultivation is permitted under Rule 20(aa)), artificial watercourse, modified

⁷Slope in Rule 25(a)(iv) is the average slope over any 20 metre distance.

- watercourse or natural wetland and a distance of 3 metres from the outer edge of the bed; and
 - (ii) cultivation does not take place more than once in any 5-year period; and
 - (iii) cultivation is for the purpose of renewing or establishing pasture and is not undertaken to establish a crop used for intensive winter grazing, even as part of a pasture renewal cycle; and
 - (iv) cultivation does not occur at an altitude greater than 800 metres above mean sea level.
- (c) The use of land for cultivation, which does not meet one or more of the conditions of Rule 25(a) or Rule 25(b) is a restricted discretionary activity.

The Southland Regional Council will restrict the exercise of its discretion to the following matters:

1. potential adverse effects of discharges of sediment and other contaminants from critical source areas in the area being cultivated on water quality and biodiversity;
 - 1a. mitigation measures for addressing adverse effects;
 3. monitoring and reporting undertaken to assess the effectiveness of any mitigation implemented.
- (d) Despite any other rule in this Plan, the use of land for cultivation at an altitude greater than 800 metres above mean sea level is a non-complying activity.

Crest

In relation to a dam, means the uppermost surface of a dam, not taking into account any camber allowed for settlement, or any curbs, parapets, guard rails, or other structures that are not part of the water-retaining structure.

Critical infrastructure

Means infrastructure that provides services which, if interrupted, would have a significant effect on the wellbeing and health and safety of people and communities and would require reinstatement, and includes all strategic facilities.

Critical source area

- (a) a landscape feature like a gully, swale or a depression that accumulates runoff (sediment and nutrients) from adjacent flats and slopes, and delivers it to surface water bodies (including lakes, rivers, artificial watercourses and modified watercourses) or subsurface drainage systems; and
- (b) areas which arise through land use activities and management approaches (including cultivation and winter grazing) which result in contaminants being discharged from the activity and being delivered to surface water bodies.

Cultivation

Preparing land for growing pasture or a crop by mechanical tillage, direct drilling, herbicide spraying, or herbicide spraying followed by over-sowing for pasture or forage crops (colloquially referred to as 'spray and pray'), but excluding any spraying undertaken solely for the control of pest plant species.

Damming

The impounding of all or part of the natural flow of any water that may involve an associated temporary or permanent structure.

Dairy farming of cows

The farming, including grazing, of milking cows on land during the milking season.

Dairy platform

An area of a landholding where dairy cows being milked on a daily basis are kept during the milking season.

Deposition

The laying down of solid material which has been carried by some natural agency (for example, rivers, wind, etc).

Diadromous

Fish that make migrations between the sea and freshwater. These migrations may be in either direction and not necessarily related to spawning.

Diversion

The redirecting of water flow from its existing direction of flow.

Domestic wastewater

For the purposes of this rule, domestic wastewater is limited to effluent derived from dwellings, business buildings, institutions and the like, and consisting of toilet wastes and wash waters from kitchens, bathrooms and laundries.
