## INTRODUCTION

- 1. This Minute contains the Hearing Panel's decision on a request for an extension to the timeframes for lodging evidence-in-chief by Chris Hansen.
- 2. Eleven previous Minutes have been issued by the Panel. A list of these Minutes is attached in Appendix 1.

## REQUEST BY CHRIS HANSEN (FOR RAVENSDOWN LTD)

- 3. In Minute 6, the Panel directed a timetable for the lodging of evidence-in-chief and rebuttal evidence for all submitters before the hearing of the submissions. In Minute 10, the dates for lodging evidence-in-chief and rebuttal evidence for all submitters were extended to 12 May 2017 and 23 May 2017 respectively.
- 4. On 2 May the Panel received a request from Chris Hansen (appearing for Ravensdown Ltd) outlining his request for an extension to the timeframes directed by the hearing panel in Minute 10 for lodging evidence-in-chief and rebuttal evidence. Mr Hansen has requested an extension as follows:
  - a. Mr Hansen's evidence-in-chief to be filed by Tuesday 16 May.
- 5. Mr Hansen has set out the following reasons for the request:
  - a. He will be overseas from 2 May until 13 May.
