#### Minute 15

### **INTRODUCTION**

- 1. This Minute contains the Hearing Panel's decision on a request for an extension to the timeframes for lodging evidence-in-chief and rebuttal evidence by Fish and Game.
- 2. 14 previous Minutes have been issued by the Hearing Panel. A list of these Minutes is attached in Appendix 1.

### **REQUEST BY FISH AND GAME**

- 3. In Minute 6, the Hearing Panel directed a timetable for the lodging of evidence-in-chief and rebuttal evidence for all submitters before the hearing of the submissions. In Minute 7 in response to a request from Fish and Game specific dates were provided for their evidence-in-chief and rebuttal evidence.
- 4. On 9 May 2017 the Hearing Panel received a request from Fish and Game outlining their request for an extension to the timeframes directed by the Hearing Panel in Minute 7 specifically for the lodging of their evidence-in-chief and rebuttal evidence. Fish and Game has requested an additional extension as follows:
  - a. Fish and Game's evidence-in-chief to be filed by **19 May 2017**.
- 5. Fish and Game has set out the following reasons for the request:
  - a. The s42A report contains recommendations to change parts of the plan based on technical advice, which the submitters only just have access to and the s42A report is a detailed report. In light of these matters and the breadth of their original submission more time is requested to prepare the evidence.
  - b. The evidence filing dates coincide with the opening of the 2017 game season which is traditionally a busy time for staff, of which some are involved in preparing evidence.

## DIRECTIONS

- 6. The Panel has considered the request and agrees to grant the extension as requested in paragraph 4.
- 7. the Panel does not consider it necessary to extend the date (26 May 2017) for filing rebuttal evidence opposing Fish and Game's evidence-in-chief.
