I am in full support of the consent be given to Mr Pirie on behalf of Lake Waituna Control Association.

Since 1969 the Lake Waituna Control Association has overseen the organising of lagoon openings. Initially the elected committee consisted of six landowners, plus one co-opted from the Acclimatisation Society. Over time however, it has been left to only the Waituna community to have representation on the LWCA, despite approaches being made to iwi, Department of Conservation etc to collaboratively hold the consent.

Over the last 53years the only constant as holders of the consent has been the Waituna community, as others have previously chosen not to be so, nor to hold the consent collaboratively, therefore the real knowledge of opening the lagoon is held by Mr Pirie and the LWCA and it is important to understand/be aware of past learnings.

The Waituna catchment land could be described as tightly held i.e. land is rarely sold to those who do not already have links to the catchment. There is significant intergenerational ownership

some of whom have whakapapa to Ngai Tahu.
I do not support the changes to conditions as in the Whakamana te Waituna Trust Review of conditions. The review acknowledges that the opening of the lagoon has an effect but it is by no means the only issue and that sediment and nutrients also have a part to play. Flood protection of farm land is the main purpose of this consent, with a consideration also for fish passage. Others have responsibility for reporting water quality e.g. ES, DoC (incl under its Ramsar obligations) etc therefore any monitoring and recording of water quality should lie with these organisations, not LWCA. These organisations are part of Whakamana te Waituna Trust so can easily share this information. There should therefore be an obligation on Whakamana te Waituna Trust to share this information with LWCA.
